Directive on Single-Use Plastic Products (and fishing gear) Directive EU 2019/904



- ✓ May 2018: Proposal by the Commission
- ✓ June 2019: adoption by the Council and EP
- ✓ 3 July 2019: Entry into force
- ✓ 3 July 2021: Transposition into national law



Plastics Strategy: actions to curb plastic waste and littering



Most found marine litter items on European beaches




- 70% covered of all marine litter: top 10 SUP (43%) + fishing gear (27%)

Directive EU 2019/904 on the reduction of the impact of certain plastic products on the environment





Beverage containers & bottles:

- product design requirements (art. 6)
- Extended producer responsibility (art. 8)
- Separate collection objective (art. 9) (only applicable to beverage bottles)
- Awareness raising measures (art. 10)

Cups for beverages:

- consumption reduction (art. 4)
- Market restriction for EPS cups (art. 5)
- Marking requirement (art. 7)
- Extended producer responsibility (art. 8)
- Awareness raising measures (art. 10)

Consumption reduction (Article 4)



- Ambitious and sustained / measurable quantitative reduction in consumption by 2026 compared to 2022 of
 - Food containers
 - Cups for beverages including covers and lids
- Member States to choose appropriate measures
 - Consumption reduction targets
 - Economic instruments
 - Increase the availability of alternatives e.g. re-usable
 - Items not provided free of charge
- National marketing restrictions for those products are only possible to substitute those products with reusable ones or with alternatives that do not contain plastics
- Monitoring and reporting obligation for MS with a view to binding quantitative Union consumption reduction targets



Market restriction (bans) (Article 5)

- Restrictions on plastic content, not the product
- Only products with readily available alternatives (single & multi use):

Commission

- Cotton bud sticks
- Cutlery
- Plates
- Straws
- Beverage stirrers
- Sticks for balloons
- All products made of oxo-degradable plastic
- Cups, food and beverage containers made of expanded polystyrene



Product design requirements (Article 6) European Commission



Tethered caps and lids to remain attached for all beverage containers and bottles up to 3 litres

5 years after the entry into force of the directive (Standardisation request)



Binding target of at least 25% of recycled plastic for PET beverage bottles from 2025 onwards, calculated as an average for the Member State, not per producer.

From 2030: 30% of recycled content for all target of at least single use plastic bottles

Marking Requirements (Article 7)



- Tobacco products with filters, cups for beverages, wet wipes and sanitary towels will require a clear and harmonized labelling on the packaging. **For cups,** the label will be on the product itself.
- The label will indicate the presence of plastics in the product, how waste should be disposed, and the resulting negative environmental impact.











Inform consumers about:

- Availability of reusable alternatives, reuse systems and waste management options
- Impact of littering
- Impact on sewer network of inappropriate waste disposal
- Notably applicable to beverage containers and cups for beverages

Extended producer responsibility (Article 8)





For food and **beverage containers, bottles**, **cups**, packets and wrappers, light weight carrier bags and tobacco products with filters

Producers will help cover the costs of:



- waste prevention (awareness raising);
- waste management (collection and treatment costs of on-thego waste in public areas);
- litter clean-up and
- data gathering.
- For wet wipes and balloons, only the waste prevention and litter clean-up costs are covered.



→ WFD minimum requirements for EPR schemes apply

Separate collection (Article 9)





Separate collection target for plastic beverage bottles

→ by 2025 - 77%

→ by 2029 - 90%

Support high quality recyclates and uptake of secondary raw materials



> Support plastic packaging recycling target of 55% by 2030

Tasks for the Commission



by October 2019	Request to the European Standardization Organization to develop a standard on tethered caps (beverage containers)
by July 2020	Implementing Act on marking
	Implementing Act on separate collection target (beverage bottles)
	Implementing Acts on reporting and quality check reports on - fishing gear placed on the market and waste collected - separate collection target (beverage bottles)
	Guidelines on items covered by Annex
by January 2021	Implementing Act on measuring consumption reduction Implementing Act on reporting and quality check reports on consumption of food containers and cups and measures on consumption reduction
by Jan 2022	Implementing Act on measuring and verifying target on recycled content (beverage bottles) Implementing Acts on reporting and quality check reports on recycling content target (for beverage bottles), and on post-consumption waste of tobacco filters with plastic
No deadline	Guidelines on EPR cost coverage Request to the European Standardization Organization to develop a standard on recyclability of fishing gear



Evaluation of the Directive in 2027

Notably:

Assessment of the need to review the list of single-use items, including plastic caps and lids used for glass and metal beverage containers

An assessment of the change in materials used in the SUP products and of the new consumption patterns based on re-usable

Assessment of the scientific and technical progress concerning criteria or a standard for biodegradability in the marine environment
